3. Send a 50% deposit ASAP as spaces are reserved on a first come, first serve basis. Send check or money order made payable to: Warren County Farmers' Fair Association to the address below.

\$	<b>Inside Space:</b> \$150.00 – 10' frontage with one 110V – 24 amp electrical outlet. There will be a charge of \$50.00 for each additional outlet used.
\$	Second inside booth – \$75.00 to make a total of 20' frontage
\$	<b>Outside Space:</b> \$70.00 for every 5 feet of frontage needed. Depth is limited. One 110V – 24 amp electrical outlet included per vendor. There will be a charge of \$50.00 for each additional outlet used. You will need to supply your own extension cord and lights if needed. Please fill in amount below. First price is the cost of the space without a tent. The price in parenthesis is the cost with a tent. (Prices subject to change)
\$	\$140.00 for 10' frontage without a tent
\$	\$210.00 for 15' frontage without a tent
\$	\$280.00 for 20' frontage without a tent OR (\$505.00 for a 25' space with a 16' X 16' tent)
\$	\$350.00 for 25' frontage without a tent OR (\$600.00 for a 30' space with a 20' X 20' tent)
\$	\$420.00 for 30' frontage without a tent OR (\$700.00 for a 30' space with a 20' frontage X 30' depth tent)
\$	\$490.00 for a 35' frontage without a tent
\$	\$560.00 for a 40' frontage without a tent OR (\$770.00 for a 40' space with a 30' frontage X 20' depth tent)
\$	For space over 40' frontage, please add \$70.00 for each additional 5 feet required
\$	<b>Overnight accommodations:</b> \$75.00 for vendors staying overnight on the fairgrounds
\$	<b>Passes:</b> As a vendor, you will receive 6 complimentary 'all week' passes. If you require additional passes, you may purchase 'one-day' passes at a cost of \$3.00 each but no later than July 15 <sup>th</sup>
\$	<b>TOTAL DUE</b> from costs above
\$	<b>TOTAL DUE</b> – this is the remaining amount due by July 1 <sup>st</sup>

Balance and certificate of liability insurance is due by July 1<sup>st</sup> or your deposit and space will be forfeited. Personal checks will not be accepted after this date and payment must be in the form of cash, money order or certified check. A \$25.00 service fee will be charged for all returned checks.
